


Our Mission

Programs and Services

Eligibility

- Ohioans over the age of 18
- Eligible for Medicaid
- Eligible for Medicare
- In need of skilled or intermediate level of care
- Individuals with physical disabilities and/or mental health needs
- Age 59 or younger
- Eligible for Medicaid
- In need of skilled or intermediate level of care
- · Adults in a home or community-based setting
- Age 60 or older
- Eligible for Medicaid in need of skilled or intermediate level of care
- Individuals age 21 or older
- Living in a community-based setting
- Have a behavioral health diagnosis, be active on the solid organ or soft tissue transplant waiting list, or diagnosed chronic condition
- May also require determination of disability by Social Security Administration
- Membership with participating MMO or other participating program^

Cecilia's Story

Cecilia is a hero. In World War II, Cecilia not only delivered provisions and contraband to Polish resistance fighters but she helped three American pilots escape Germany. Cecilia is an outgoing woman, eager to share stories of her incredible life, sing songs, and speak in one of the seven languages she knows. Unfortunately,

Cecilia struggles with the loss of her eyesight, cardiac concerns, and mobility issues. After starting a kitchen fire due to her poor eyesight, Cecilia knew it was time to get some help.

Since joining our program, Cecilia has been connected with an aide who assists Cecilia with cooking, cleaning, and other chores. The best part for Cecilia is that her aide, Ella, speaks Polish! Cecilia is able to converse with Ella in her native tongue and now has a connection to her homeland. Cecilia is grateful that her Care Manager, Patty, was able to find such a perfect match for her.

Bonnie's Story

Bonnie's husband was diagnosed with Alzheimer's and they didn't qualify for Medicaid. Then Bonnie got sick too. She couldn't take care of her husband. She couldn't even climb steps because her hips and knees couldn't take the strain. She thought that her only choice was to place her husband in a nursing facility. Thankfully, Bonnie



decided to find an alternative. She contacted Direction Home Aging & Disabilities and she and her husband were placed in the Care Coordination program.

Direction Home provided Bonnie and her husband with an aide who helped with household chores and provided personal care for Bonnie's husband. Sadly, Bonnie's husband lost his battle shortly after. The Care Coordination program continues to provide an aide for Bonnie to help with the household chores. Bonnie says that it is good to know that her Care Manager is there, helping her to remain independent. "This program is wonderful. I don't want to leave my house unless I absolutely have to."
